NOW BEFORE THE BOARD of Commissioners sitting regularly for the transaction of County business on the 21st day of July, 1976, is the matter of creating the Coos-Curry Regional Housing Authority;

AND IT APPEARING to the Board that the Board of Commissioners for Curry County has determined that there exists unsanitary and/or unsafe inhabited dwelling accommodations in Curry county, and that within the County there is a shortage of safe or sanitary dwelling accommodations available at rents which persons and family of lower incomes can afford, and that such persons and family are forced to occupy overcrowded and congested dwelling accommodations;

AND IT FURTHER APPEARING to the Board that the Board of Commissioners of Coos County has similarly found that the above recited conditions exist and that there is a need for safe and sanitary dwelling accommodations available at rents which persons and family of lower income can afford;

AND IT FURTHER APPEARING to the Board that it would be expediant, appropriate and in the best interest of the citizens of both counties to join in the creation of a regional housing authority to undertake and develop programs to assist those residents of Coos and Curry Counties who have been found to have need therefore;

AND IT FURTHER APPEARING to the Board that ORS 456.075 allows the County to declare, by resolution, the need for a housing authority to function within this County;

AND IT FURTHER APPEARING to the Board that ORS 456.095 and ORS 456.040 allows the County to join with and co-operate with another county or city government to create a regional housing authority to exercise all the powers inferred by the housing authority law;

AND IT FURTHER APPEARING to the Board that the Coos County Commissioners have, prior to this date, made a similar

resolution establishing a regional housing authority;

NOW, THEREFORE, IT IS RESOLVED AND ORDERED that the Coos-Curry Regional Housing Authority is created with those powers and obligations imposed by Oregon Law;

IT IS FURTHER ORDERED that the (Coos-Curry) Regional Housing Authority is to be officially known as Coos-Curry Housing Authority.

NOW BEFORE THE BOARD of Commissioners sitting regularly for the transaction of County business on the 21st day of July, 1976, is the matter of the appointment of Commissioners to the Coos-Curry Regional Housing Authority;

AND IT APPEARING to the Board that the successful operation and effectiveness of the Coos-Curry Regional Housing Authority depends upon a dedicated and qualified board of citizens to be constituted and to serve as Commissioners of the Coos-Curry Regional Housing Authority;

AND IT FURTHER APPEARING to the Board that the resolution and order of this date creating the Coos-Curry Regional Housing Authority was adopted by the Board of County Commissioners for Curry County and a similar resolution was adopted by Coos County;

AND IT FURTHER APPEARING to the Board pursuant to ORS 456.095 that it is the responsibility of the Board of County Commissioners of each county to appoint four commissioners to function as the governing body of the housing authority;
