BY-LAWS

BE IT RESOLVED BY THE HOUSING AUTHORITY

OF THE CITY OF NORTH BEND, OREGON

That the following by-laws be and they are hereby adopted and approved as and for the by-laws of the Housing Authority of the City of North Bend, Oregon:

BY-LAWS OF THE HOUSING AUTHORITY

OF THE

CITY OF NORTH BEND, OREGON

ARTICLE I - THE AUTHORITY

Section 1. Name of Authority. The name of the Authority shall be the "Housing Authority of the City of North Bend".

Section 2. <u>Seal of Authority</u>. The seal of the Authority shall be in the form of a circle and shall bear the name of the Authority and the year of its organization.

Section 3. Office of Authority. The office of the Authority shall be at such place in the City of North Bend, Oregon, as the Authority may from time to time designate by resolution.

ARTICLE II - OFFICERS

Section 1. Officers. The officers of the Authority shall be a Chairman, a Vice Chairman and a Secretary who shall be Executive Director.

Section 2. Chairman. The Chairman shall preside at all meetings of the Authority. Except as otherwise authorized by resolution of the Authority, the Chairman shall sign all contracts, deeds and other instruments made by the Authority. At each meeting the Chairman shall submit such recommendations and information as he may consider proper concerning the business, affairs and policies of the Authority.

Section 3. <u>Vice Chairman</u>. The Vice Chairman shall perform the duties of the Chairman inthe absence or incapacity of the Chairman; and in case of the resignation or death of the Chairman, the
